

EXPRESSION OF INTEREST FOR EOI/NGP/6005/113 PIPING BOLT AND GASKETS FOR THE NYANZAGA GOLD PROJECT

Sotta Mining Corporation Limited (Sotta) is a Tanzanian incorporated joint venture company 84% owned by Perseus Mining Limited (Perseus) and 16% by the Government of Tanzania.

Sotta is developing the Nyanzaga Gold Project (Nyanzaga or Project) located within the southern area of the Lake Victoria Gold Fields, north-western Tanzania.

Sotta is in the process of developing the Project which includes the design and build of a gold processing plant, open pit mine, and associated infrastructure.

Sotta is seeking Expression of Interest (EOI) for the following upcoming scope of work for the Nyanzaga Gold Project:

Sotta invite companies interested and qualified in delivering this scope of work to submit Expression of Interest, which must address the following compliance criteria:

Expression of Interest Compliance Criteria:

- a) Detailed company information including ownership (provide shareholder % of ownership), organisational structure and details of any Tanzanian operating entity including evidence of local content compliance with the Tanzania Mining Commission or verification of eligibility to apply.
- b) Confirmation of the entity's ability and commitment to establish an entity which is local content compliant in accordance with the Tanzanian Mining Act, and particularly the Mining (Local Content) Regulations 2018 and any subsequent amendments.
- c) Details of current packages in process as well as evidence of successful delivery of similar scope of work to the mining industry over the last 10 years with the following details provided:
 - i. name of the project and client.
 - ii. brief scope of work.
 - iii. value of scope of work (indicate the applicable currency).
 - iv. delivery or installation date of the scope of work; and
 - v. contact details of a minimum of three (3) references for each project.
- d) If applicable, details of the Original Equipment Manufacturer (OEM) the company will engage with for delivery of the scope of work, including:
 - i. name of the OEM
 - ii. contact details of the company's liaison officer at the OEM, or the OEM's representative covering the Tanzanian market.

- e) A copy of the company's sample Quality Management Plan, including a copy of a valid ISO9001:2015 accreditation.
- f) A copy of audited financial reports to verify company's financial capacity to deliver the scope of work
- g) Ability to supply in accordance with AS 1111 and AS 1112:
 - Hexagonal head steel machined Property Class 4.6 bolts and Property Class 5 nuts, zinc passivated.
 - Hexagonal head steel machined Property Class 8.8 bolts and Property Class 8 nuts, zinc passivated
 - h) Ability to supply gaskets
 - o 3.0mm thick Kilngersil KGS GII
 - o 1.5mm thick Klingersil C4430
 - i) Ability to supply Grade 250 min. Galvanised U-bolts with sizes ranging from 15mm to 900mm diameter.
