

**EXPRESSION OF INTEREST FOR  
EOI/NGP/114 EXPLOSIVES SUPPLY AND SERVICES  
FOR THE NYANZAGA GOLD PROJECT**

Sotta Mining Corporation Limited (Sotta) is a Tanzanian incorporated joint venture company 84% owned by Perseus Mining Limited (Perseus) and 16% by the Government of Tanzania. Sotta is developing the Nyanzaga Gold Project (Nyanzaga or Project) located within the southern area of the Lake Victoria Gold Fields, north-western Tanzania. Nyanzaga is in the Sengerema District within the Mwanza Region of Tanzania. The Project area lies approximately 60 km southwest of Mwanza. Sotta is in the process of developing the Project which includes the design and build of a gold processing plant, open pit mine, and associated infrastructure.

Sotta is seeking Expression of Interest (EOI) for the following upcoming scope of work for the Nyanzaga Gold Project:

Sotta invite companies interested and qualified in delivering this scope of work to submit Express of interest, which must address the following compliance criteria:

**Expression of Interest Compliance Criteria:**

- a) Detailed company information including ownership (provide shareholder % of ownership), organisational structure and details of any Tanzanian operating entity including evidence of local content compliance with the Tanzania Mining Commission or verification of eligibility to apply.
- b) Confirmation of the entity's ability and commitment to establish an entity which is local content compliant in accordance with the Tanzanian Mining Act, and particularly the Mining (Local Content) Regulations 2018 and any subsequent amendments.
- c) Evidence of capability to perform the scope of work for a major Mining operation of similar size and nature to Nyanzaga Gold Project, including:
  - I. Demonstrate the capability to finance and procure equipment sufficient to handle ~ 500T of explosives monthly.
  - II. Demonstrate access to experienced personnel capable of managing, maintaining and operating Explosives plant.
- d) Details of current services being performed as well as evidence of successful delivery of similar scope of services over the last 5 years with the following details provided:
  - I. Name of the project.
  - II. Name of the client.
  - III. Brief scope of services.
  - IV. Value of the services (indicate the applicable currency).
  - V. Commencement and completion dates.
  - VI. Contact details of a minimum of three (3) references for each project.
- e) Copy of the company's Health, Safety and Environmental (HSE) policy, sample HSE Management Plan and HSE statistics for the last 3 years.
- f) A copy of the company's sample Quality Management Plan, including a copy of a valid ISO9001:2015 accreditation.
